





For the past 15 years Gregg Thomas has dedicated his life to the pursuit of educating the public on musky fishing. As a full time guide he starts his season in the southern waters of Cave Run and Green River Lakes in Kentucky. As the season progresses he moves to central Minnesota and fishes the Mille Lacs area. As a writer he has been published in several national publications such as Musky Hunter Magazine, Midwest Outdoors and Fishing Facts. He is also a seminar speaker that has spoken at several Muskies Inc. Chapter meetings, sport shows and sports store events. The final media outlet that Gregg has become involved in is Television and Video. He has appeared on Musky Hunter Television, Keyes Outdoors, Badfish videos and in 2006 he released his own video, Gregg Thomas' "Blueprints to Musky Success: Vol. 1 Weed Fishing." Lastly are Gregg's tournament accomplishments. Having fished the majority of the Professional Musky Tournament Trails events Gregg has become a very accomplished angler, winning the "Top Gun" award twice in 1999 and 2006. He also won two tournaments, including the PMTT World Championship in 1999 and has over a dozen top ten finishes. Gregg enjoys his job and loves teaching people about musky fishing. So if you would, let him share with you some tips that he might have picked up along the way at the seminar.

PROGRAM DIRECTOR

For the last few years I've been fortunate enough to be able to attend the DNR's annual Roundtable event. The event is a pretty big deal. It's a two day gathering that brings together people from every conservation organization and every sporting interest in Minnesota to meet with decision makers and management positions from the DNR. There are a lot of presentations, discussions, and information sharing, and it's a great place to meet outdoor writers, legislators, DNR managers, and sportsmen from all accross the state.

At this year's Roundtable, John Underhill, co-chair of the MN Muskie and Pike Alliance, gave a presentation on what the MMPA has been doing and what we hope to accomplish. One of the three main topics of his presentation was the "Bonus Pike Limits" idea that we've been considering. It's a possible method of addressing overabundant "hammer-handle" pike issues on some lakes. Second was our proposal to increase the size limit on muskies, and third was the continued effort to stock muskies in Lake Tetonka. The good news is that none of these topics have brought any negative feedback since the Roundtable, and all three seem to be gaining public acceptance. We've been talking directly with the DNR and hopefully things will keep flowing smoothly.

At our last chapter meeting the idea was brought up to look into implementing some sort of catch & release "state record" for muskies. Basically it would be a catch/photo/measure type system that would allow released fish to be registered for record keeping. It's a progressive idea that would allow recognition of the huge fish Minnesota is producing as well as recognition to the anglers lucky enough to catch a real giant, all without killing these awesome fish. I think it's a cool idea and would be a major stepping stone towards keeping those big fish swimming. We talked about this a little bit at the last MMPA meeting too. People seemed to like the idea, and we even got indication that some DNR personnel have already discussed this as a possibility. Right now this is nothing more than an idea floating around, but maybe it's something we'll be able to get behind in the near future.

Things are quiet on the legislative front so far, but keep your eyes open... it's that time of year again. Don't forget, our seminar with Gregg Thomas on February 11th is at a new location- the Moose Lodge in Waite Park.
