## **PROGRAM DIRECTOR REPORT . . . . .** By Aaron Meyer

Each year, there are muskies kept by anglers hoping they've caught the new state record. Unfortunately, these fish never end up weighing what the angler hoped, and the fish is killed for nothing. Catching a state record fish is the ultimate goal for many anglers, and a new official record would lend legitimacy to Minnesota's muskie stocking program, but losing these top end fish does nothing for our fisheries. In the last few years, at the DNR Esox Workshops, we've occasionally brought up the idea of a Catch and Release state record for muskies.

The DNR recently informed us that they'll be implementing a new Catch and Release state record program, beginning this year. The program will initially be for muskies, lake sturgeon, and flathead catfish, because these species are largely targeted by C&R minded anglers. If the program catches on, eventually other species will be included as well.

The Master Angler program came up in our conversations, but we expressed concern that it did not provide the notoriety that people are looking for when they catch a really large fish. That program just doesn't get any press, and certainly doesn't provide the recognition record class fish deserve. So, the DNR plans to implement their own program, and would like it to eventually be carried by the Freshwater Fishing Hall of Fame, possibly in conjunction with the Master Angler program.

The details of the program are not fully finalized yet. The real key to this program will be angler involvement. We need to embrace this program and encourage anglers to utilize it. It will only become a "real" record in the public's eye if people get on board and register their big fish. It will obviously take a few years to catch a lot of attention, but with some of the huge fish caught in recent years, it should have no problem getting going. This program has the potential to bring recognition to Minnesota's great fisheries, and help preserve those fisheries at the same time. Stay tuned

We've been talking a lot about the potential changes for pike management. The DNR recently finished compiling all of the input they received on the proposal. They've released a document that addresses the concerns and questions people had. Please read the following document:

The proposed new muskie waters need your help!

The opposition to muskie stocking is rising. While the arguments are just the same old false information about muskies harming other fish populations, the threat to our stocking program is real. A wealthy lakeshore owner is actively traveling across the state presenting false information to every Legislator, lake association, and local government agency that will listen. After being fed these lies about muskies, many lake associations, city councils, county commissions, and other local government agencies are actually passing resolutions to ban muskie stocking in their areas!

The current stocking proposals are in jeopardy. If they beat us on this, it will set a precedence for attacking the stocking programs on our muskie lakes statewide. We are working to combat this in several ways. It's time to address this issue with DNR Commissioner Tom Landwehr. He is the focal point where science based fisheries management meets politics and public sentiment.

### **Here's what we need:**

Support from local businesses always carries significant weight in these issues. Minnesota businesses should send emails to the Commissioner supporting the stocking proposals and the expansion of the muskie program.

This can be ANY business that supports and/or benefits from muskies. Some examples would be guides, lure manufacturers, bait shops, tackle companies, retailers, television hosts, boat dealers, boat manufacturers, gas stations, hotels, and restaurants. **Every business, no matter how big or small.** Try to think of anyone you have contact with- call them and ask them to do this. These businesses don't need to commit to anything big, or put their support for muskies on public display. Just a simple email to the DNR Commissioner is all we ask.

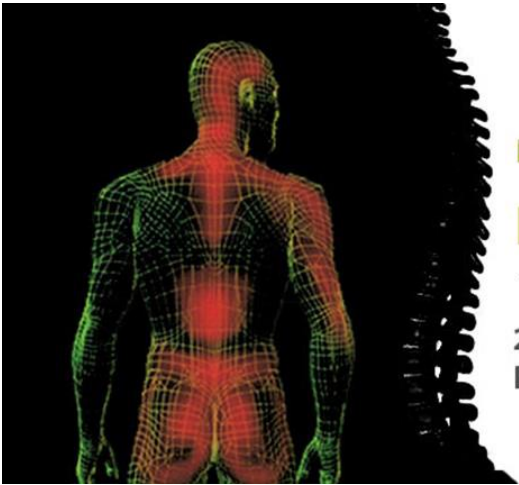

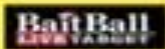
