PROGRAM DIRECTOR REPORT By Aaron Meyer

Many of you have been following the situation in Ottertail County regarding the muskie stocking program on Pelican Lake. We had an excellent turn-out at the meeting in Fergus Falls, showing the DNR and the Legislators that people from all across Minnesota support muskie stocking and sound fisheries management practices. The DNR did an excellent job of explaining and defending their muskie program. The group fighting against muskie stocking had filed an injunction against the DNR to stop them from stocking Pelican Lake.

Well, if you haven't already heard... a judge threw out the injunction and this year's quota of PIT tagged fingerlings has now been stocked! This was a huge win for muskies, and fisheries management as a whole!

Over the last several years, it has often felt like there's a never ending procession of issues coming up against muskie management. Throughout that timeframe, I feel that the muskie angling community as a whole has become

more involved and increasingly active in protecting and promoting our fisheries. The harder they hit us, the stronger we become! We have now justified and proven the muskie management program scientifically, publicly, legislatively, and in the court system. Thank you all for your continuous support!

So now, on to the next issue! This one is a good one. The DNR has remained committed to their Long Range Plan for muskie management, which calls for 5 more muskie lakes to be stocked by the year 2020. They have chosen the lakes they are proposing, have posted the proposals in the appropriate public venues, and it is now time for us to provide our input!

As in the past, there will be public meetings for people to provide input, and there are also several ways to provide input if you cannot make it to one of the meetings. My suggestion is to make the appropriate phone calls, and/or emails, and also attend one or more of the meetings, if possible. Your input via phone call or email counts equally as someone who attends a meeting, but I can tell you that there is always a stronger statement made by showing up in person. It really means a lot.

There will be separate meetings in each part of the state where lakes are being proposed, and there will also be a meeting in Andover that will pertain to all of the proposals. Below is all of the contact information for you to provide input, as well as the date/location of each meeting. All of the meetings are from 7:00-9:00pm. All of this information is also available on the home page of the DNR website at www.mndnr.gov/ And, there is a link on that page to provide input directly. Please support ALL of the proposals!

Lake Alexander Outing Recap and 2016 Club Outing on Big Mantrap

As I type this I hope people are on the lake seeking one last shot at a fall giant before the season ends or the ice appears! Five members from the chapter joined up with the Brainerd Chapter for their Iceman Challenge on Lake Alexander on November 14th. My son and I moved 3 fish but couldn't get them to eat. New member Chad Berger was fishing with Tom Ardolf and was able to get his first fish in the net - congrats Chad! Tom had the fish come in behind his bait and she swung off and ate Chads sucker! Teamwork at its finest and a 46" November fish was in the bag! There have been two SCMI outings this fall and all the fish have been caught by new members - that's fantastic!



2016 SCMI Club Outing - Big Mantrap!

I am currently trying to plan a 4 day outing to Big Mantrap next fall from September 15-18 which is a Thursday-Sunday with the full moon on Friday. I've spent some time on Mantrap the last couple seasons and I like it more every time I go and I think it would make a great place for a SCMI outing! The lake is a 2.5 hour drive up the road and is located about 20 miles NE of Park Rapids. It's 1600 acres but fishes much larger with an abundance of shoreline and mid lake structure and has a great "up north" feel to it with minimal shoreline development. Any size boat could navigate Mantrap easily and find places to fish out of the wind. We also have a current SCMI member who knows the lake well and said he would attend the outing and share his knowledge!

Norway Hills Resort is on the lake and as of now they have cabins we can rent at a reduced rate from the summer pricing - check out their website- <https://www.norwayhills.com> The pricing quoted was for an 8 person cabin and if we had 8 people the cost would be \$158 plus tax per person for the 4 days/3 nights with dockside electrical and trailer parking included. Pricing really depends on how many people go and if we can fill up the cabin(s) or not.

There is also tent camping available at the Mantrap Lake Campground and Day Use Area adjacent to the main launch for those who may not want to stay at the resort. From the DNR website: "The campsites are considered "primitive", designed to furnish only the basic needs of the camper. The campsites consist of a cleared area, fire ring, and table. Vault toilets, garbage cans, and drinking water are available. All sites are on a first come, first-served basis". Cost is \$14 per night and is required via registration envelopes available at the campground.

Please let me know as soon as possible if you are interested in going on this outing - even if you are a "maybe". The cabins will need a 20% deposit placed on them to make the reservation and I would like to make the reservations by the January meeting. Get the vacation time lined up now! 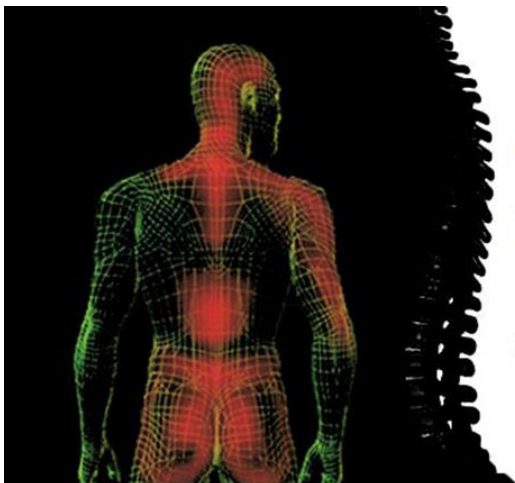
